An Employer's Perspective:

Employment opportunities for paralegals are expected to grow faster than the national average, with an approximate growth rate of 18%. As organizations seek to cut costs and improve efficiency, paralegals are increasingly given responsibilities once managed by lawyers. The growing population and an increase in demand for legal services have also increased the demand for paralegals. However, it has become an increasingly popular occupation and competition for positions will continue to increase. Candidates with strong computer, database management, and writing skills are in demand.

Salaries:

According to the Bureau of Labor Statistics, the median pay for paralegals and legal assistants nationwide was \$46,990. However, salaries are dependent upon the industry, level of position, and geographical region.
