

DELAWARE LAW AND STEVENSON UNIVERSITY PARTNERSHIP

Overview

Stevenson and Widener University Delaware Law School [Delaware Law] offer two special admissions programs for Stevenson undergraduate students: a 3+3 Early Admission Program and an Express or Guaranteed Admissions Program.



3+3 Early Admission Program

Stevenson Legal Studies Program students may earn both a bachelor's degree and a juris doctor degree in six years, instead of the usual seven, provided they:

- Complete at least 75% of their bachelor's degree, including all Stevenson Educational Experience general education and Legal Studies Program requirements, before enrolling at Delaware Law
- Complete at least 18 credits (6 classes), with a C or better, contributing toward the Legal Studies major, with at least six of those credits at the 300-400 level
- Earn a cumulative undergraduate GPA of 3.0 or higher through six semesters of undergraduate studies at Stevenson
- Achieve an LSAT score that meets or exceeds the median LSAT score of the current Delaware Law first-year entering class
- Satisfy all law school admissions requirements relating to character and fitness
- Submit a completed application to Delaware Law no later than April 1st of the calendar year in which the student plans to begin legal study

Students admitted to Delaware Law through the 3+3 program must attend on a full-time basis until they have completed their bachelor's degree. At that time, they may elect to continue their legal studies on either a full- or part- time basis.

Students in the 3+3 Early Admissions Program will have Delaware Law send an official transcript to Stevenson at the completion of their first year of law school. Stevenson will award the bachelor's degree to students who have successfully completed the first year of law school and completed all major and core requirements at Stevenson.

DELAWARE LAW AND STEVENSON UNIVERSITY PARTNERSHIP

Express or Guaranteed Admission Program

Stevenson students will be admitted to Delaware Law if they:

- Complete all degree requirements at Stevenson before enrolling in courses at Delaware Law
- Earn a cumulative undergraduate GPA of 3.0 or higher through time of law school application review
- Achieve an LSAT score that meets or exceeds the median LSAT score of the current Delaware Law first year entering class
- Satisfy all law school admissions requirements relating to character and fitness
- Submit a completed application to Delaware Law no later than April 1st of the calendar year in which the student plans to begin legal study

Students admitted through the Express or Guaranteed Admission Program have the option of attending either full- or part-time.

Merit Scholarship Award

Delaware Law will offer a minimum merit scholarship to all Stevenson students who are admitted through the 3+3 or the Express Admission Program. This award will be renewable provided the student maintains good academic standing at Delaware Law. The award will be subject to terms and conditions outlined at time of acceptance.

All financial aid applications will be handled directly between the student and Delaware Law. Delaware

Law will consider Stevenson students for any need-based financial aid for which they would be normally considered.
