

General Disclosure for Programs Meeting Licensure or Certification Requirements

PROGRAMS: Nursing, B.S.; Nursing, ATB

As set out in the 1 November 2019 Final Rules in the Federal Register, the U.S. Department of Education requires that all institutions make public information regarding a program’s ability to meet the licensure requirements for a particular state.

The programs customarily leading to licensure at Stevenson University have been designed to meet the licensure/certification requirements in Maryland as well as prepare students to apply for licensure exams in the State of Maryland. Students who intend to return or move to any state other than Maryland are advised to review the professional licensure disclosures pertaining to their program.

The chart below provides professional licensure disclosure information for the Stevenson University Bachelor of Science Degree in Nursing and Associate to Bachelor’s Program in Nursing. Please direct questions to Dr. Vanessa Velez, Associate Dean, School of Nursing and Health Professions.

Stevenson University’s pre-licensure nursing options prepare students to be certified by the Maryland Board of Nursing to sit for the national NCLEX exam. Some states may require additional coursework in order to be eligible to sit for the NCLEX exam and receive a nursing license. These states are indicated as “No” or “Not Determined” in the chart below.
