THIS IS TO CERTIFY:

FIRST: That we, the subscribers, Harry J. Dingle, whose post-office address is 5425 Springlake Way, City of Baltimore, State of Maryland; Agnes H. Dingle, whose post-office address is 5425 Springlake Way, City of Baltimore, State of Maryland; and Mary R. Hopkins, whose post-office address is 4504 Old Frederick Road, City of Baltimore, State of Maryland; all being of full legal age, do under and by virtue of the General Laws of the State of Maryland authorizing the formation of corporations, associate ourselves with the intention of forming a Corporation.
